## NEW BUSINESS

2. **OPP – 2024 2<sup>nd</sup> Quarter Operations/Statistical Analysis Report** – The Board considered the 2024 2<sup>nd</sup> Quarter Operations Summary and Statistical Analysis report with respect to policing the Town of Caledon by Inspector N. Majer, OPP Caledon Detachment Commander. The reports provided statistics and analysis for April - June 2024 for the following areas:

- Public Complaints
- Motor Vehicle Collisions
- Criminal Code and Provincial Statute Charges Laid
- Violent Crime
- Property Crime
- Drug Crime
- Clearance Rates

L. Carby congratulated Inspector N. Majer on her appointment as Caledon's Detachment Commander and inquired about the 68.4% increase in Criminal Code Highway Traffic Act charges from 2023 to 2024. He asked for the factors driving this rise and the strategies being implemented to address it. Inspector Majer explained that the increase was due to proactive enforcement and additional staffing during the quarter, though future staffing levels remain uncertain.

A. Boughton congratulated Inspector N. Majer on her appointment and requested a report comparing the number of speeding tickets issued on Highway 10 this quarter to the previous one. He also asked for details on how many of these tickets were issued during off-hours and the times of day when violations were most frequent. Additionally, he referenced an incident involving a trucking company owner who faced threats and shootings at his home, indicating plans to discuss the matter further with Inspector Majer.

Inspector Majer highlighted the value of community engagement through foot patrols and expressed her commitment to addressing community concerns in discussions with A. Boughton. She also urged residents to call 911 immediately if they feel threatened or face an urgent safety issue.
